GENERAL TERMS

1. The Urja Mitra kendras, Resident welfare associations, Educational institutions, NGOs etc who are interested in offering their services for ANERT can register through Google form available in the ANERT Website.
2. ANERT on receiving the applications, will scrutinize them and short list the campaign partners and those who are selected be published in ANERT Website.
3. Upon selection, all empaneled campaign partners will be allotted with a unique identification number. Campaign partners will be provided incentives @ Rs.250/- (Rupees Two hundred and fifty only) based on the confirmed orders towards campaign expenditure. Registered organisation have to use the Unique ID as promo code while registering the beneficiary in the BUYMYSUN portal.

4. The name of any campaign partners from the empanelment list can be terminated without notice, in case of their nonexistence/ other violations.
5. This empanelment list will be the one and only one for the registration of beneficiaries in buymysun portal and they shall not have any right to suggest products in buymysun. Selection of products in buymysun will be sole responsibility of the beneficiary.
6. The Applicant for the empanelment should not have any pending litigation with ANERT.
7. ANERT reserves the right to cancel the empanelment list without any further notice.
8. ANERT reserves the right to include/ Exclude the agencies without any prior Notice.
