APPLICATION FOR E VEHICLES (E CARS)

INTRODUCTION

As per the G.O(Ms).No.58/2018/Trans dated 29.09.2018, the Govt of Kerala has issued draft E Vehicle policy for the state of Kerala.



As per the G.O.(P)No.24/2020/Fin dated 07/03/2020 from Finance Dept, Govt of Kerala, has ordered that, all the Govt Departments are directed to hire only Electric Cars from EESL through ANERT. It is also ordered that all the Heads of the Departments are directed to hire Electric Vehicles by replacing the already hired Diesel/Petrol vehicles with effect from 01.04.2020.

For this purpose, ANERT is introduced E-Mobility project for providing various types of Electric vehicles to Government Departments on Lease/hiring.

E CARS PROJECT DETAILS

- ➤ E-car: Battery Operated Electric Car and associated accessories
- > Presently Available E Cars- TATA TIGOR/ MAHINDRA EVERITO and HYUNDAI KONA
- Available Lease Options: Dry Lease (Without Driver) and Wet Lease (with Driver).

Dry Lease E Cars: (Without Driver)

- ➤ TATA Tigor/ Mahindra E Verito- Rs. 22,500/- per Month with 10% Annual Escalation upto 6 Years without fuel cost.
- ➤ Hyundai KONA Electric- Rs. 50,000/- per Month with 10% Annual Escalation upto 8 Years without fuel cost.
- ➤ GST is applicable to above mentioned amounts as actual.
- ➤ Minimum period of Contract is 6 Years for TATA TIGOR/ MAHINDRA EVERITO and 8 Years for HYUNDAI KONA.

Monthly Limit shall be 2400 kM. For Vehicle running more than 2400 kM in a month, Rs 3/kM shall be extra charged.

Wet Lease E Cars: (With Driver)

- ➤ TATA Tigor/ Mahindra E Verito- Rs. 40,000/- per Month with 10% Annual Escalation upto 6 Years
- ➤ Hyundai KONA Electric- Rs. 80,000/- per Month with 10% Annual Escalation upto 8 Years.
- ➤ GST is applicable to above mentioned amounts as actual.
- ➤ Minimum period of Contract is 6 Years for TATA TIGOR/ MAHINDRA EVERITO and 8 Years for HYUNDAI KONA.
- ➤ In Wet Lease (with Driver) Number of Working days in a month would be 26 days. For usage of e-car services beyond 8 hours of service in a day, Extra charges of INR 200/ hour would charged from Organization.
- ➤ In wet Lease, Monthly lease would include the driver's Salary. Overtime would be charged extra.
- ➤ Monthly Limit shall be 2400 kM. For Vehicle running more than 2400 kM in a month, Rs 3/kM shall be extra charged.

General Terms and Conditions

- > Delivery period after supply order shall be minimum of 45 days.
- Monthly contract amount for three months shall be paid to ANERT as security deposit at the time of Executing the Agreement.
- ➤ ANERT will raise invoice between 1st or 5th day of every month for the previous month. The ORGANIZATION would make payment to ANERT before 20th day of the month, post which ANERT would charge Liquidated Damages @ of 12% per annum of the invoiced amount from the date of receipt of the invoice till the date of actual payment. Further, the right to levy liquidated damages is without prejudice to the other available legal rights or remedies to ANERT.
- For Mahindra e Verito or Tata Tigor, Vehicle can run Maximum of 120 kM at full charge and for Hyundai KONA, can run maximum of 400 kM at full charge.

- ➤ Batteries of the E Vehicles can be charged during night time. 6-8 hours required for full charge. In public charging stations (DC Fast charging), it will take 0.5 to 1.5 hours for full charge.
- ➤ The expenses on account of parking, toll, Electricity Charge on account of charging of cars, etc. would be borne by the Organization.
- > The Organization will provide dedicated location, space and all the necessary arrangement for installation of charging unit. The Organization will also provide Electrical wiring work from supply point to the location specified for installation of charger.

Warranty and AMC Conditions

➤ Minimum Contract period is 6 Years. Free Maintenance period will be 5 years or 1,00,000 kM (whichever is earlier). After this period, the expenses for maintenance shall be borne by client.

The Warranty does not cover the following:

- As such for parts as tires, 12 V batteries (low voltage), seats, music system, body parts, etc. this warranty shall not apply.
- ➤ Warranty shall not cover normal wear and tear or any inherent normal deterioration of the car or any of its part arising from actual usage of the car or any damage due to negligent or improper operation or storage of the car.
- ➤ Warranty shall not apply to normal maintenance services viz. oil and fluid changes, head lamps focusing, fastener tightening, wheel balancing, tyre rotation, wiper blade/rubber and consumable like light bulbs and normal deterioration of sensory feels like noise, touch and texture of particular components.
- > The repair works of Master cylinder, wheel chamber, calipers, discs after 50,000 kM.
- ➤ The repair works of Brake pads/liners/drums not included.

The AMC does not cover the following:

- > Any loss or damage to the items, which are not part of the original vehicles leased by ANERT
- > Damage caused to the vehicles, which has not been serviced or maintained in accordance with the OEMs's recommendations and as per the operator manual
- > Damage resulting out of the customer not taking reasonable steps to safe guard the vehicles from loss or damage and to maintain it in efficient condition.

- Any break down/damage caused by any type of accident or any act of omission, which is willful, unlawful, negligent or fraudulent.
- Any repairs/replacement arising from accident, collision damage, burglary, theft, force majeure or any other accidental external means, riots, terrorism, malicious damage etc.
- ➤ Legal liability for death or bodily injury or property damage.
- ➤ Consequential loss of any kind. It is hereby clarified that in the event of any damage caused to the vehicles which is directly attributable to the Company, the Company's liability shall in no event exceed the amount actually paid by the Customer for the AMC.
- ➤ Any damage arising as a result of the vehicles being used for any sort of competition, sport or rally, reliability trial
- ➤ If the vehicles is rendered non-road worthy due to mishandling, tampering, accident, negligence, fire any other act of nature, the repairs shall not be covered under the "Scope of Repair" and the Dealer reserves the right to charge the customer for repairs thereof including its labour charge

SPECIAL CONDITIONS

- ➤ The lock-in period for the contract is 36 / 48 months. In case, Organization terminates the Contract before end of 36 / 48 months'; then Organization will serve a notice period of at least 90 (Ninety) days to ANERT. ORGANIZATION has to pay, without demur, "Termination Payment for Lock-in-Period as per below, discounted at the rate of 8% per annum, in case of termination before the end of lock-in Period
 - Before the lock-in period, the ORGANIZATION shall pay all the remaining lease payments
 - Post completion of Lock-in-Period, Organization can only terminate the agreement only if ANERT is at default under the terms of this Agreement, subject to cure as provided under this Agreement or as agreed otherwise between the Parties.
- ➤ In case of a damage to assets, and there being a difference between the cost incurred on repair as against the claim amount received from the insurer, your organization shall be solely responsible for payment of the differential amount (Including applicable insurance deductibles).
- ➤ In case of repair/ replacement of a part which is not covered under vehicle warranty/ AMC, your organization would be required to bear the cost.

- > Your organization shall appoint a nodal officer, who shall be single point of contact and shall be responsible for all coordination activities on behalf of your organization.
