ORDER

As per reference read 1 above, e Tender notification was published for inviting Expression of Interest from OEMs, authorised distributors of OEM, public sector institutions and Government Agencies for the supply / installation of off grid solar powered devices below 1 kW. Documents for Expression of Interest were submitted by seven agencies vide reference 2 read above. On scrutiny of all the pre-qualification criteria and certification for technical compliance of devices, four Agencies were qualified in the evaluation of technical bids for installation of solar street lighting / flood lighting systems as per reference 3 read above. The Agencies already qualified as per reference read 5 above will also be continued. It was also noticed that three Agencies were qualified in the evaluation of technical bids for supply of solar domestic lights. The price bids submitted by all these Agencies were opened vide reference 4 read above.

The rates quoted by these Agencies are within the benchmark costs suggested for the empanelment process and hence five Agencies are approved for installation of LED Solar Street Lighting / Flood Lighting Systems within the State of Kerala. The following are the Agencies qualified for Empanelment for installation of LED Solar Street Lighting / Flood Lighting Systems through ANERT and Local Self Govt. Institutions.

The validity period of the empanelment will be two years as indicated in the Annexures of this order. As per the circular of Local Self Govt. Department referred 6 above, guideline was issued for the implementation of solar projects through various Local Self Govt Institutions by inviting tenders from the Agencies empanelled by ANERT for the purpose. The list of empanelled agencies for installation of solar street lighting and solar flood lighting systems is enclosed as Annexure I and the list of empanelled agencies for supply of solar domestic lights is enclosed as Annexure II. Technical specification for solar LED street lighting / flood lighting systems is enclosed as Annexure III and that for solar domestic lights as Annexure IV. List of components of solar LED street lighting / flood lighting systems is enclosed as Annexure V and that of solar domestic lights as Annexure VI. Any change in the make and model number of components approved for the work should be done with prior sanction from ANERT. This revised list of Empanelled Agencies may be followed by the Local Self Govt Institutions for their tender process for the installation of Solar LED Street Lighting Systems and for the procurement of solar domestic lights. The empanelment list will be updated from time to time.
