Sealed competitive quotations are invited for the Supply, Installation and Commissioning of Hot, Cold and normal (RO + UV) based Water Purifier for the use at ANERT HQ, Thiruvananthapuram from the manufacturers or authorised dealers with good track record in this field on buy back terms and conditions with AMC. 
The bidders should quote the rates for the Supply, Installation and Commissioning of Water Purifier including 3 years of warranty and the rate for AMC thereafter in the schedule of quantities as appended (Annexure – II). Envelope containing the quotations should bear the superscription addressed as per the form of Quotation Notice and should reach the Directorate by Hand/Post/Courier.

The brochure (Make and Model) along with technical specifications of the water purifier being quoted and the details of dealership are to be provided along with the bid. The price of spares/components not covered under warranty/AMC in the format as in Annexure – III must be provided along with the quotes and no increase in prices for these spares will be considered. It is mandatory to change the filter at-least once a year

or as informed by the personnel at ANERT. The payment shall be released on successful commissioning of the water purifier and submission of invoice along with warranty card.

The full address of the firm should be given on the sealed envelope. Last date and time for receipt of quotations is 13/11/2020 at 3.00 PM. Late quotations will not be accepted. The quotations will be opened at 4 PM on 13/11/2020 in the presence of the tenderers or their authorised representatives who are present at the time of opening. The rate quoted should be inclusive of all taxes, transportation charges, loading/unloading charges, installation charges and all other expenses.

Sealed quotations are invited for the works specified in the list above. The rates quoted should be for the complete works mentioned in the schedule. The necessary superscription, due date for the receipt of quotations, the date up to which the rates will have to remain firm for acceptance and the name and address of officer to whom the quotation is to be sent are noted above. Any quotation received after the time fixed on the due date is liable to be rejected. Quotations not stipulating period of firmness and with price variation clause are liable to be rejected. The acceptance of the quotations will be subject to the following conditions.

1. Withdrawal from the quotation after it is accepted or failure to supply within a specified time or according to specifications will entail cancellation of the order and purchases being made at the offers expenses from elsewhere, any loss incurred thereby being payable by the defaulting party. In such an event the Government reserves also the right to remove the defaulter's name from the list of Government suppliers permanently or for a specified number of years.
2. No representation for enhancement of price once accepted will be considered during the currency of the contract.
3. Any attempt on the part of tenderers or their agents to influence the Officers concerned in their favour by personal canvassing will disqualify the tenderers.
4. If any license or permit is required, tenderers must specify in their quotation and also state the authority to whom application to be made.
5. The prices quoted should be inclusive of all taxes, duties, cesses, etc., which are or may become payable by the contractor under existing or future laws or rules of the country of origin/supply or delivery the course of execution of the contract.
6. Any sum of money due and payable to the successful tenderer or contractor from Government shall be adjusted against any sum of money due to Government from him under any other contracts.
7. Payment will be made only after completing the works upon the satisfactory performance of the work awarding authority.
8. Special conditions, if any, printed on the quotation sheets of the tenderer or attached with the tender will not be applicable to the contract unless they are expressly accepted in writing by the purchases

TECHNICAL SPECIFICATIONS

1. Should be RO+UV Water Output of above 15 Litre Per Hour
2. Should be 230 V input power supply
3. Should have 12 litres or above tank capacity with automatic filling
4. The water purifier must have adequate height so that the water can be dispensed easily after placing the purifier in the ground
5. Should provide MS stand with rollers, if in built rolling wheels are not available with the water purifier being provided
6. Installation should be done at free of cost.
