ORDER

ANERT is creating an eco-system to cater the requirements of the State to achieve the Renewable Energy targets set forth by the State and Central Governments. ANERT plans to list System Integrators / EPC contractors in the Renewable Energy sector through a vendor Registration Process. For this, ANERT has appointed M/s ICRA Analytics Ltd vide ref cited 1st to undertake the Grading of all such prospective vendors enabling ANERT to directly list such vendors based on the Grading provided by ICRA Analytics. ANERT had invited Expression of Interest for listing of agencies for undertaking installation of Solar Power Plants undertaken by ANERT and two phases of the process were completed. The updated list of vendors was published vide ref cited 2nd.

This process of Vendor Registration is envisaged as a continuous process and hence another EoI (Phase – 5) was floated vide ref cited 3rd and there are 16 bidders in this EoI who had submitted for registration. Among these, 1 bidder has not submitted the requisite grading certificate and hence need not be considered. The updated list of vendors along with their Grading are given below:

1. LIST OF PROGRAMMES / MODE OF IMPLEMENTATION

- i. This list of Vendors will be eligible to undertake works of ANERT for installation of grid connected, off-grid & Hybrid solar power plants. These installations could be under CAPEX / RESCO / BOOT mode.
- ii. The vendors listed are based on the Pre-Qualifications conditions and criteria set forth for the Vendor Registration process. The works done through ANERT, will be monitored and Supervised at every stage and the Quality Assurance of the components and service rendered will be assured only if the works are done through ANERT. The use of the list of vendors for installation of Solar Power Plants directly by any other LSGs / Departments / Organisations will be at their own risk and ANERT will not have any obligation in such works. Hence, the works under this listing is limited through Deposit Work Mode / Project Management Consultancy mode of ANERT. The listed vendors are also restricted from obtaining direct works from any Department / LSG using this order.
- iii. ANERT is the Nodal agency for implementation of Solar Power Plants in Public buildings and Proposed Solar City at Thiruvananthapuram. All activities to be undertaken by ANERT shall be implemented through these listed vendors.
- iv. Price offers will be invited for various capacities of grid connected, Off Grid and Grid connected solar plant with battery backup as and when required.
- v. ANERT will be acting as a PMC for Government Institutions who wish to install Power Plants on CAPEX / RESCO mode. All (Some) of Such works can be implemented through this list of vendors. ANERT may also award the installation part to these vendors if required, provided the materials will be procured directly by ANERT.
- vi. ANERT may also fix rate contract for installation if a particular programme demands so. This list will not be applicable for installations made under any Financial Assistance schemes of MNRE.

2. ALLOCATION OF CAPACITY

The capacity of Solar Power Plant that can be allotted to a particular vendor depends on their grading issued by M/s ICRA Analytics Limited, which is determined using the experience and financial strength of the vendor. Based on the grading, the

vendors will be listed in certain categories as below:

3. TECHNICAL REQUIREMENTS

- i. The implementation of the projects should be in accordance with technical compliance required by ANERT / MNRE, CEA, KSERC Regulations. The detailed technical requirements are attached as annexure I.
- ii. Technical compliance certificate/ Test report from the approved laboratory of MNRE, NABL, IEC, BIS accredited has to be submitted for the main system components (solar PV module, Power conditioning unit, Battery) of all the models and brands proposed. The certificate should be valid as on the date of submission. Vendors are free to use the components listed by ANERT from time to time and the above documents are not required in that case.
- iii. ANERT will be verifying the installations through ANERT District Engineers / Accredited Solar Power Plant Inspectors (ASPPI) and the directives from ANERT, based on the recommendation of the inspectors has to be incorporated and installation has to be modified, if required.
- iv. The Compliance of technical parameters and prescribed installation practices has to be adhered to and the violators will be removed from the list and the details will be made available to the public for information. Disciplinary action also will be initiated based on the gravity of the issue.
- v. Warranty as mentioned in the tenders / EoIs being floated must be provided for the entire system as per the conditions of the contract. The Copy of warrantee certificate from manufacturer of module and PCU and Battery has to be given to the beneficiary institution as an attachment to the warrantee certificate of the Vendor
- vi. Any complaint or service call from the beneficiary has to be attended within 48 hours and problems have to be rectified within 7 days

4. VALIDITY

- i. The validity of the list will be for a period of two years from the date of issue of this order and this list will be updated as and when required.
- ii. The vendors are free to renew their grading at any point of time and ANERT will update the allocation accordingly as per clause No. 2. This is mandatory for all vendors upon completion of 1 year of issue of the list.
- iii. ANERT in its discretion is free to remove any vendor from the list of vendors at any point of time on reasonable grounds

5. TERMS AND CONDITIONS FOR THE RATE CONTRACT

This Vendor Registration process shall be governed by the terms and conditions of the tender vide Tender ID: - 2021_ANERT_458898_1,

2021_ANERT_458898_2, 2021_ANERT_458898_3, 2021_ANERT_458898_4 & 2021_ANERT_458898_5 and all corrigendum issued thereof. All the terms and conditions as per the EoI document is part of this process. The CEO, ANERT solely reserves the right to cancel/modify/extend this list without assigning any reason.

The acceptance of this process shall be acknowledged with 7 days with a copy of this order duly signed. In case, any of the agencies fail to comply the same, they stand removed from the ANERT List of Vendors for Solar Power Plant installations.
