This e-Tender is being published for the Supply, Installation & Commissioning of 4 Nos. of (20W/Model-C) Solar Street Lighting Systems at Udumbanoor Grama Panchayath, Idukki. The tender is invited in single cover system through e-procurement portal of Government of Kerala (<u>www.etenders.kerala.gov.in</u>). Prospective bidders willing to participate in this tender shall be an empanelled agency approved by ANERT for the installation of Solar Street Lighting Systems during the year 2024 and shall necessarily register themselves with above mentioned e-procurement portal.

1. ONLINE BIDDER REGISTRATION PROCESS:

- i. Bidders should have a Class III or above Digital Signature Certificate (DSC) to be procured from any Registration Authorities (RA) under the Certifying Agency of India. Details of RAs will be available on <u>www.cca.gov.in</u>. Once, the DSC is obtained, bidders have to register on <u>www.etenders.kerala.gov.in</u> website for participating in this tender. Website registration is a one-time process without any registration fees. However, bidders have to procure DSC at their own cost.

2. ONLINE TENDER PROCESS:

The tender process shall consist of the following stages:

- Downloading of tender document: Tender document will be available for free download on <u>www.etenders.kerala.gov.in</u>. However, tender document fees shall be payable at the time of bid submission as stipulated in this tender document.
- ii. Pre-bid meeting: (not applicable)

- iii. Publishing of Corrigendum: All corrigenda shall be published on <u>www.etenders.kerala.gov.in</u> and shall not be available elsewhere.
- iv. Bid submission: Bidders have to submit their bids along with supporting documents to support their eligibility, as required in this tender document on <u>www.etenders.kerala.gov.in</u>. During the online bid submission process, bidder shall select *SBI MOPS* option and submit the page, to view the *Terms and Conditions* page. 9. BIDDER'S LOCATION

- i. The bidders are requested to furnish the exact location of their factories/godown with detailed postal address and pin code, telephone and fax nos. etc. in their tenders to arrange inspection by ANERT if considered necessary.
- ii. All communication shall be made to the registered email of the bidder in the etendering systems and ANERT shall not be responsible for non-receipt or delay of any such communication.

10. CORRUPT AND FRAUDULENT PRACTICES

ANERT requires compliance with its policy in regard to corrupt and fraudulent/prohibited practices as set forth in this proposal. In further pursuance of this policy, the selected service Provider(s) shall permit ANERT or its representatives to inspect the accounts, records and other documents relating to the submission of the Proposal and execution of the contract, in case of award, and to have the records inspected by ANERT.

11. CONFLICT OF INTEREST

- i. 12. CONFIDENTIALITY

- i. Information relating to the evaluation of Proposals and award recommendations shall not be disclosed to the agency (ies) who submitted the Proposals or to any other party not officially concerned with the process, until the publication of the Contract award information.
- ii. Any attempt by the agency (ies) or anyone on behalf of the Suppliers to influence improperly ANERT in the evaluation of the Proposals or Contract award decisions may result in the rejection of its Proposal and may be subject to the application of prevailing Government sanctions procedures.
- iii. Notwithstanding the above provisions, from the time of the Proposals" opening to the time of Contract award publication, if agency (ies) intends to contact ANERT on any matter related to the selection process, it should do so only in writing.

- j. The lowest bidder L1 has to submit at least 50 % of the materials at sites within two weeks of issue of the work order, failing which second lowest bidder L2 will be given opportunity, provided he is agreeing to match the rate and supply materials with similar conditions.

CONDITIONS OF CONTRACT

18. GENERAL CONDITIONS

- i. The tenders should be submitted online at <u>www.etenders.kerala.gov.in</u>
- ii. The tenders should be as per the prescribed form which should be downloaded from the website <u>www.etenders.kerala.gov.in</u>. The cost of tender forms should be paid online, and once paid will not be refunded. Tender forms are not transferable. Tenders that are not in the prescribed form are liable to be rejected.
- iii. Intending tenderers should submit their tenders on or before the due date and time mentioned in the tender abstract. Late tender will not be accepted.
- iv. The rates quoted should be only in Indian currency. Tenders in any other currency are liable to rejection. The rates quoted should be for the unit specified in the schedule attached.
- v. The tenderer shall submit a copy of PAN card of the authorised signatory along with tender.
- vi. Every tenderer should send along with his tender an Earnest Money Deposit. This may be paid online at the e-tenders website.
- vii. If any tenderer withdraws from his e-tender before the expiry of the period fixed for keeping the rates firm for acceptance, the earnest money if any, deposited by him, will be forfeited.
- viii. The final acceptance/rejection of the tenders rests entirely with CEO, ANERT who do not bind themselves to accept the lowest or any tender.
- ix. In the case of materials of technical nature, the successful tenderer should be prepared to guarantee satisfactory performance for a period of guarantee under a definite penalty. Communication of acceptance of the bid normally constitutes a concluded contract. Nevertheless, the successful bidder shall also execute an

agreement for the due fulfilment of the contract within the period to be specified in the Registration order to be issued. The contractor shall have to pay all stamp duty, Lawyer's charges and other expenses incidental to the execution of the agreement. Failure to execute the agreement within the period specified will entail the penalties set out below:

- a. A non –refundable licensing fee of 2.5% has to be remitted by tenderer for all the works undertaken by them on behalf of ANERT. - xi. In all cases where there are guarantee for the goods supplied, the security deposit will be released only after the expiry of the guarantee period.
 - a. All payments to the contractors will be made by ANERT/concerned in due course as mentioned in this document.
 - b. All incidental incurred by ANERT for making payments outside the State in which the claim arises shall be borne by the contractor.
- xii. Payments will be made only after the supply, Installation and Commissioning of the items and certification by the competent technical personnel of ANERT.
- xiii. The contractor shall not assign or make over the contract on the benefits or burdens thereof to any other person or body corporate. The contractor shall not underlet or sublet to any person or persons or body corporate the execution of the contract or any part thereof without the consent in writing of the purchasing officer who shall have absolute power to refuse such consent or to rescind such consent (if given) at any time if he is not satisfied with the manner in which the contract is being executed and no allowance or compensation shall be made to the contractor or the subcontractor upon such rescission. Provided, that if such consent be given at any time, the contractor shall not be relieved from any obligation, duty or responsibility under this contract.
- xiv. In case the contractor becomes insolvent or goes into liquidation, or makes or proposes to make any assignment for the benefit of his creditors or proposes any

composition with his creditors for the settlement of his debts, carries on his business or the contract under inspection or behalf of or his creditors or in case any receiving order(s) for the administration of his estate are made against him or in case the contractor shall commit any act of insolvency or in case in which under any clause or clauses any act of insolvency or in case in which under any clause(s) of this contract the contractor shall have rendered himself liable to damages amounting to the whole of his security deposits, the contract shall, thereupon, after notice given by the Purchasing Officer to the contractor, be determined and ANERT may complete the contract in such time and manner and by such persons as ANERT shall think fit. But such determination of the contract shall be without any prejudice to any right or remedy of ANERT against the contractor or his sureties in respect of any breach of contract committed by the contractor. All expenses and damages caused to ANERT by any breach of contract by the contractor shall be paid by the contractor to ANERT and may be recovered from him under the provisions of the Revenue Recovery Act in force in the State.

In case the contractor fails to supply and deliver any of the said articles and things or the works within the time provided for delivery of the same, or in case the contractor commits any breach of any of the covenants, stipulations and agreements herein contained, and on his part to be observed and performed, then and in any such case, it shall be lawful for ANERT (if they shall think fit to do so) to arrange for the purchase of the said articles and things from elsewhere of on behalf of ANERT by an order in writing under *the* hand of the CEO put an end to this contract and in case ANERT shall have incurred sustained or been put to any costs, damages or expenses by reason of such purchase or by reason of this contract having been so put an end to or in case any difference in price, compensation, loss, costs, damages, expenses or other moneys shall then or any time during the continuance of this contract be payable by the contractor to ANERT under and by virtue of this contract, it shall be lawful for ANERT from and out of any moneys for the time being payable or owing to the contractor from ANERT under or by virtue of this contract or otherwise to pay and reimburse to ANERT all such costs, damages and expenses they may have sustained, incurred or been put to by reason of the purchase made elsewhere or by reason of this contract having been so put an end to as aforesaid and also all such difference in price, compensation, loss, costs, damages, expenses and other moneys as shall for the time being payable by the contractor aforesaid.

- xvi. Any sum of money due and payable to the contractor (including security deposit returnable to him) under this contract may be appropriated by the CEO or any other person authorised by ANERT and set off against any claim of ANERT for the payment of a sum of money arising out of or under any other contract made by the contractor with ANERT or any other person authorised by ANERT. Any sum of money due and payable to the successful tenderer or contractor from ANERT shall be adjusted against any sum of money due to ANERT from him under any other contracts.
- xvii. Every notice hereby required or authorised to be given may be either given to the contractor personally or left at his residence or last known place of abode or business, or may be handed over to his agent personally, or may be addressed to the contractor by post at his usual or last known place of abode or business and if so addressed and posted, shall be deemed to have been served on the contractor on the date on which in the ordinary course of post, a letter so addressed and posted would reach his place of abode or business.
- xviii. The tender shall undertake the installation and commissioning of the system according to the standards and specification.
 - xix. No representation for enhancement of rate once accepted will be considered.
 - xx. The prices quoted should be inclusive of GST and all other expenses which are or may become payable by the contractor under existing or future laws or rules of the country of origin/supply or delivery during the course of execution of the contract.
 - xxi. The tenderer will invariably furnish the required certificates with their bills for payment –

A solar street lighting system consists of a PV Module, control electronics, storage battery, W-LED based Luminaire, interconnecting cables and module mounting pole including hardware and battery box. The luminaire is based on White Light Emitting Diode (W-LED), a solid-state device which emits light when electric current passes through it. The luminaire is mounted on the pole/ mast at a suitable angle to maximize illumination on the ground. The PV module is placed at the top of the pole facing South direction at an inclination of 10 degree from horizontal. The system should be installed at a place where direct sunlight falls on the PV modules without any hindrance. There should not be any shadows falling on the PV modules during daytime. The battery placed inside the battery box is charged by electricity generated by the PV module during daytime and the luminaire provides light from dusk to dawn. The system lights at dusk and switches off at dawn automatically. During the dusk to dawn operation, the brightness of the LED will be reduced by 50% for 4 hours for saving power from 12 mid night to 4 am (Timing subject to site specific conditions)

- b. The terms of payment shall be:
 - i. 2.5 % of the invoice amount including 18% GST shall be charged by ANERT as non-refundable license fee and the remaining amount shall be treated as contract value for further payment.

25. DUTY CYCLE

• The W-LED solar street lighting system should be designed to operate from dusk to dawn, under average daily insolation of 5.0 kWh /sq m on a horizontal surface.

26. LUMINAIRE

- The light source will be of white LED type. The colour temperature of white LED used in the system should be in the range of 5000°K–6500°K. Use of LEDs which emits ultraviolet light is not permitted.
- The light output from the white LED light source should be constant throughout the duty cycle. Proper lens to be provided for the LED for effective lumen spread.
- The lamps should be housed in an assembly suitable for outdoor use. It should be made of pressure die cast aluminium. The temperature of heat sink should not increase more than 20°C above ambient temperature during the dusk to dawn operation.

27. BATTERY

28. PV MODULE

- The power output of the PV module must be reported under standard test conditions (STC) at 16.4-volt load voltage. I-V curve of the sample module should be submitted.
- iii. The open circuit voltage of the PV modules under STC should be at least 21.0 volt.
- iv. The PV module efficiency should be above 14 %.
- v. The terminal box on the module should have a provision for opening for replacing the cable, if required.
- vi. Each PV module should be provided with RF identification tag. The following information must be mentioned in the RFID used on each module (This can be inside or outside the laminate but must be able to withstand harsh environmental conditions.)
 - a) Name of the Manufacturer or distinctive Logo
 - b) Model or Type No.
 - c) Serial No.
 - d) Year of make

29. ELECTRONICS INCLUDING PROTECTION.

- i. The total electronic efficiency should be at least 90%.
- ii. Electronics should operate at 24V/36V/48V and should have temperature compensation for proper charging of the battery throughout the year.
- iii. The light output should remain constant with variations in the battery voltages.
- iv. The system should have protection against battery overcharge and deep discharge conditions.
- v. Fuse should be provided to protect against short circuit conditions.

- vi. A blocking diode should be provided as part of the electronics, to prevent reverse flow of current through the PV module(s). In case such a diode is not provided with the PV module, full protection against open circuit, accidental short circuit and reverse polarity should be provided.
- vii. The charge controller should be in corporate with MPPT. Programmable facility should be incorporated for regulating dimming of the luminaire.
- viii. Adequate protection to be provided against battery reverse polarity
 - ix. Adequate protection is to be incorporated under No Load conditions.
 - x. Load reconnect should be provided at 60% of the battery capacity status.
 - xi. Necessary lengths of wires / cables and appropriate fuses should be provided.

30. MECHANICAL COMPONENTS AND INSTALLATION.

- i. Aluminum frame structure, with anodizing to be fixed on the pole to hold the SPV module. The frame structure should be inclined at an angle of 10 degree from the horizontal to mount the PV module. The luminaire should be fixed to the pole on aluminium arm. 32. OTHER FEATURES

- There will be a Name Plate (12" X 6") on the pole (2 m above ground level), which should be displayed with the following details
 - a) Name of the supplier.
- b) Phone number of service centres.
- c) Date of installation.
- d) Name of Implementing Agency.
- ii. Necessary lengths of wires/cables and fuse should be provided.
- iii. Quality stickers with post number will have to be provided on the pole.

33. QUALITY AND WARRANTY

- i. Components and parts used in White LED solar street lighting systems should conform to the latest BIS/ International specifications, wherever such specifications are available and applicable. A copy of the test report/ certificate stating conformity of BIS/ International standards must be submitted.
- ii. White LED solar street lighting system including the battery will be warranted for a period of 5 years from the date of commissioning.
- iii. The PV module used should be warranted for its output peak watt capacity, which should not be less than 90% at the end of 10 (ten) years and 80% at the end of 25 (twenty five) years.

34. DOCUMENTATION

An Operation, Instruction and Maintenance Manual, in English and Malayalam, should be provided with the solar street lighting system. Besides other information the Manual should contain the following minimum details:

- b) About White LED solar street lighting system its components and expected performance The make, model number, country of origin and technical characteristics of W-LEDs should be stated in the product data sheet
- c) Clear instructions about mounting of pole, grouting details, fixing of PV module, battery and luminaire, clear wiring instructions with line diagram
- d) About significance of indicators
- e) DO's and DONT's
- f) Clear instructions on regular maintenance and trouble shooting of the system
- g) Name and address of the person or service centre to be contacted in case of failure or complaint.

35. INSURANCE

a. The street lighting systems must be insured at every stage of operation – from Material dispatch, storage, completion of installation and till 5 years after commissioning. The insurance coverage on handing over of the system must include all conditions of Standard Fire and Special Perils Policy (Material Damage) and Burglary & Theft Insurance Policy.
