ORDER

As per the reference 1st cited, Dept. of Power, Govt. of Kerala had issued Administrative sanction for implementation of Solar Powered Public EV charging stations with state subsidy. As part of this programme, ANERT had invited expression of interest for empanelment of agencies (Notification No. ANERT -TECH/269/2020-PE2(EV)) for the implementation of solar powered public EV charger Project.


As per the reference 2nd cited, we have already empaneled 10Nos of agencies for installation of Solar EV Charging Stations. Presently we have received documents for other 11 nos of agencies. All the empanelment documents were verified by the the Technical committee and found that 7 nos of agencies were technically qualified for empanelment of solar powered public EV charging stations under ANERT. The validity of this empanelment is one year from the date of issue of this order.

All the terms and conditions in the empanelment document should be strictly followed during the implementation of this project. Agencies should install only ANERT approved EV charging machines for ensuring the quantity of solar powered public EV charging project. The guidelines for implementation of Solar EV Charging Stations should also be strictly followed while implementing this Project.
