ORDER

MNRE had sanctioned Solar Grid Connected Power Plants with an aggregate capacity of 10MWp and released Rs.6,48,90,000/- as first instalment of CFA as per ref 1 dtd 19.12.2017. The amount was distributed to beneficiaries and sent UC to MNRE. Now as per ref.1 dtd 26.2.2021, MNRE had released the 2nd Instalment of CFA of Rs.4,78,50,050 and the amount was distributed to beneficiaries and sent UC to MNRE.

Now MNRE had released Rs 4,67,14,118/- as final instalment of CFA and settled the account finally. The subsidy due to the Institutional beneficiaries (Buy My Sun) against the sanction cited above are as follows.
